- B) ORDINANCE 2025-12 AN ORDINANCE ENACTING SECTION 521.07 OF PART FIVE GENERAL OFFENSES CODE, OF THE CODIFIED ORDINANCES OF THE VILLAGE OF HUNTING VALLEY TO ESTABLISH A PROHIBITION AGAINST CAMPING ON PUBLICLY OWNED AND CONTROLLED PROPERTY, AND PUBLIC RIGHTS-OF-WAY AND DECLARING AN EMERGENCY.**

Victor Strauss submitted his reports for the Service Department and provided several updates on ongoing Village projects. Old Kinsman culvert replacement will start in December and will go through May of next year. Our mill and fill program will be starting next week, and Van Curen will be doing tree work in the village over the next few months.

Mr. Jerry Medinger then moved to adjourn into executive session to discuss the compensation of village employees. Mr. Don Bullock seconded the motion.
